Masongsong for the immediate recall of CASURECO II Project Supervisor/Acting General Manager, Engr. Nelson Lalas because of his continued incompetent and insensitive management that is proving detrimental to CASURECO II member-consumers and the general public;

WHEREAS, CASURECO II is continuously benefitting and thriving, spurred by the economic growth within its coverage area, particularly Naga City;

WHEREAS, it is a mega-large electric cooperative, earning multi-million in revenue and net profit, and claims to have improved in its categorization for the year 2017 that can be attributed to the collective and cohesive efforts of its employees, particularly its highly-qualified and seasoned Management Staff;

WHEREAS, with due respect to the supervisory functions of NEA as provided by law, CASURECO II is not an ailing electric cooperative whose potential for progressing economic growth is immeasurable and therefore should be manned by people whose competence and management befits the position, and whose heart is with the people and communities he serves and protects--sensitive and cognizant of their needs and empathizing with their ideals and sentiments;


