RESOLUTION GRANTING THE ROPALI CORPORATION, THROUGH MR. CHRISTOPHER S. CAPISTRANO, HEAD, BUSINESS PLANNING AND RESEARCH GROUP, TO CONDUCT A TEST RUN FOR THREE (3) E-TRIKE UNITS, SUBJECT TO CERTAIN TERMS AND CONDITIONS:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the 1st Indorsement dated April 27, 2018 of Mr. Christopher S. Capistrano, Head, Business Planning and Research Group, ROPALI Corporation seeking approval of their intent to conduct economic and product endurance testing for electric tricycle units for a period of three (3) months;

WHEREAS, finding the conduct of a test run to be in order and necessary to determine the viability of the E-Trike units of ROPALI Corporation;

NOW, THEREFORE, on motion of Hon. Joselito S.A. del Rosario, seconded by Hon. Mila S.D. Raquid-Arroyo, Hon. Salvador M. del Castillo and Hon. Tomas Ramon A. Sanchez Jr.;

BE IT RESOLVED, as it is hereby resolved, grant the ROPALI Corporation, through Mr. Christopher S. Capistrano, Head, Business Planning and Research Group, to conduct a test run for three (3) E-Trike units, subject to the following terms and conditions:

1. The test run shall be for the period of ninety (90) days;
2. Only three (3) units of E-Trike shall be allowed in the test run;
3. The units shall not be allowed to ply national roads;
4. The Traffic Management Center of the Public Safety Office and the Naga City PNP shall look into the allowable number of passengers, the safety of the driver and passengers, and shall regularly update the Sangguniang Panlungsod on the status of the test run, and to render a terminal report after the 90-day period.




