

RESOLUTION CONFIRMING THE ACCEPTANCE OF THE DONATION, AND RATIFYING THE DEED OF DONATION EXECUTED BY MR. CANUTO DE LA CRUZ REPRESENTED BY MR. EMETERIO DE LA CRUZ WITH RESPECT TO THREE (3) ROAD LOTS COVERED BY TCT NO. 598 WITH AN AREA OF 11,158 SQUARE METERS LOCATED AT BARANGAY BALATAS, NAGA CITY, AS ACCESS ROAD OF THE RESIDENTS OF SITIO MANGAPO-GAPO, CONCEPCION PEOPEÑA, THIS CITY:-

DEED OF DONATION

Know all men by these presents:

This **DEED OF DONATION** made and executed by and between:

CANUTO DE LA CRUZ, represented by **EMETERIO DE LA CRUZ**, Filipino, of legal age married to Dolores De la Cruz with residence and postal address at Canuto Village, Sitio Mangapo-gapo, Zone 2, Concepcion Pequeña, Naga City, Camarines Sur, hereinafter called the **DONOR**;

and

The CITY GOVERNMENT OF NAGA, a Local Government Unit created under the laws of the Republic of the Philippines, represented herein by Mayor JOHN G. BONGAT, who is of legal age, married and with office address at City Mayor's Office, 2nd Floor, City Hall Building, J. Miranda Avenue, Naga City, herein after called the **DONEE**.

WITNESSETH

That the **DONOR**, thru his representative as Attorney-in-Fact, an owner in fee simple of a parcels of land under TCT No. 598 covering an area of 11,158 square meters located at Barangay Balatas, Naga City wherein portion thereof is the subject of this instrument more particularly described as follows:

That for and in consideration of the support of the DONOR to the DONEE's continuing program on socialized housing especially to the residents of Sitio Mangapogapo, Barangay Concepcion Pequeña, Naga City, the DONOR hereby transfers and convey the above described lot subject to the following conditions, to wit:

- a. That a concrete road shall be constructed on the donated lands as an access road to and fro the Canuto Village, Sitio Mangapo-gapo, Concepcion Pequeña, Naga City;
- b. That a suitable drainage system shall be established to prevent flooding caused by the road construction.
- c. That the DONEE hereby undertakes, for itself and the beneficiaries, not to sell, alienate, mortgage or in any manner dispose of the donated property without prior consent from the DONOR.

That the DONOR hereby guarantees that the subject property is free from liens and encumbrances, and that it has reserved for itself sufficient property to support itself in a manner appropriate to its needs.

That the DONEE shall shoulder all expenses for Donor's Tax, Transfer Tax, Registration of Donation and all other incidental expenses necessary for transfer.
