WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter dated June 19, 2018 of Engr. Frederick M. de Real, OIC Manager, Bicol Branch, Social Housing Finance Corporation, requesting the city government to sign in a Memorandum of Understanding with the SHFC to address the shelter needs and reactivate the city's accreditation as accredited CMP mobilizer;

WHEREAS, on January 30, 2018, the Sangguniang Panlungsod adopted Resolution No. 2018-042, creating the Technical Working Group (TWG) for the formulation of the New-Towns Development Plan in the implementation of the city's "One-Time-Big-Time" thrust for its Socialized Housing Program and, once approved by the city government, monitor the implementation thereof;

WHEREAS, in line with its desire to effectively respond to the needs of the Nagueño families for decent shelter and better quality of life, the City Government of Naga has remained steadfast in its commitment to sustain and continually improve the programs being implemented for the purpose;

WHEREAS, towards this direction, the city government can work hand in hand with the Social Housing Corporation through the Home Mortgage Program in the implementation and materialization of the "One-time, Big-Time Project;

WHEREAS, finding the same to be in order and necessary in the furtherance of the city's Socialized Housing Program;
