WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter dated June 29, 2018 of Ms. Vilma V. Salvino, President, CAPAJODA, seeking assistance for possible site where to transfer their terminal due to the two (2) weeks period given by the lot owner within which to vacate its present terminal at De la Rosa Compound in Barangay Dinaga, this city;

WHEREAS, in her letter dated July 16, 2018, Ms. Salvino informed the SP Committee on Transportation that the LCC Terminal Management approved their proposal to transfer to the Southbound Integrated/Intermodal Transport Terminal at Felix Plazo, Sabang, this city;

WHEREAS, this approval of the LCC Terminal Management was confirmed by Mr. Ric Mendez, Terminal Administrator, through his letter dated July 23, 2018, approving the transfer not only the CAPAJODA PUJs but they may also accommodate the PUJs plying Centro-Panicuason-Pacol-San Isidro-Cararayan;

WHEREAS, finding the same to be in order;

NOW, THEREFORE, on motion of Hon. Joselito S.A. del Rosario, seconded by Hon. Salvador M. del Castillo;

BE IT RESOLVED, as it is hereby resolved, to allow the Carolina-Panicuason Jeepney Operators and Drivers Association (CAPAJODA) and the PUJs plying Centro-Panicuason-Pacol-San Isidro-Cararayan to utilize as temporary terminal the Southbound Integrated/Intermodal Transport Terminal at Felix Plazo, Sabang, Naga City, and directing the CAPAJODA to coordinate with the Naga City Police Office (NCPO) and Public Safety Office (PSO) for appropriate traffic management.




