# MEMORANDUM OF AGREEMENT

2018 Naga City Transport Study

### KNOW ALL MEN BY THESE PRESENTS:

The CITY GOVERNMENT OF NAGA, a local government unit with principal office at City Hall, Juan Miranda A venue, Naga City, 4400 represented by its Mayor, John G. Bongat, and herein referred to as the "CGN"

and

The ATENEO DE NAGA UNIVERSITY, with principal office address at Ateneo Avenue, Naga City 4400 and is registered with the Securities and Exchange Commission, SEC Registration No. 973, as a non-profit service organization, represented by its President, Fr. Roberto Exequiel N. Rivera, S.J. and herein referred to as the "ATENEO"

#### WITNESSETH THAT:

Whereas Tricycles are the main public transportation means in Naga City so that in

1994, in an effort to facilitate the wide provision of public tricycle services to the City's populace, an ordinance on Intra-City Trimobile

Transport and Rationalization Plan (INTRAP) was enacted;

Whereas in recent years, the Naga city's development, with the numerous

economic, educational, medical, and cultural activities being held in the city, has led to the increase in the city's daytime population and the growth of demand for tricycle services by the riding public. It became apparent that many of the rules and regulations outlined in INTRAP are

no longer being observed.

Whereas the Sangguniang Bayan of the City passed ordinance no. 2016-050

mandating the revision and upgrading the INTRAP and creating a

technical working group (TWG) to conduct a comprehensive study;

the said TWG is interested to know the city people's desire with regard Whereas

to the continued provision of transport services by the traditional tricycles and its volume/number, the volume/number of e-tricycles, and

adoption of a stage fare or graduated fare system, among others;

Whereas the CGN recognizes the capabilities and competence of the ATENEO particularly its unit, the Ateneo Social Science Research Center (ASSRC) to

conduct this survey;

Whereas

the ATENEO signifies its willingness to commit its capabilities and efforts in running the survey;

Now, therefore, for and in consideration of the foregoing premises, the CGN and the ATENEO do hereby agree to be bound by the following terms and conditions.

- The CGN shall be committed to pay the ATENEO the amount of THREE HUNDRED THOUSAND PESOS ONLY (P300,000.00) for the following services rendered by the ATENEO:
  - Training of enumerators on the use of questionnaire and field sampling procedures;
  - b. Drawing of sample spots;
  - c. Coding, cleaning, and processing of data
  - d. Technical writing of the transport study
- The CGN shall approve the survey questions that the ATENEO through ASSRC will prepare;
- 3. The ATENEQ through the ASSRC will draw a sample size of 810 survey respondents to be distributed proportionately throughout the twenty seven (27) barangays having a margin of error of ±3.4;
- The ATENEO assumes the right to publish the results of the 2018 Naga City Transport Survey;
- The ATENEO shall have access to the 2018 Naga City Transport Study for its own research needs;
- The ASSRC agrees to undertake the 2018 Naga City Transport Study for a period of one month and two weeks starting upon the signing of this Memorandum of Agreement to the submission of the final technical report to the CGN; and
- 7. The CGN shall release to the ATENEO the amount equivalent to seventy percent (70%) of the total project cost of 300,000.00 as stipulated above, and representing PhP210,000.00 upon signing of this Memorandum of Agreement and another thirty percent (30%) of the total project cost, the final payment or PhP70,000.00, upon submission of the final technical report.

This Memorandum of Agreement shall take effect upon signing hereof by both the parties and shall remain in full force within the period stipulated above.
