WHEREAS, the Sangguniang Panlungsod received the 20 September 2018 letter of the City Mayor requesting for Authority to enter into a Memorandum of Agreement (MOA) by and between the City Government of Naga, represented by Hon. Mayor John G. Bongat, and SM Prime Holdings, Inc., represented by its duly authorized representative;

WHEREAS, the proposed Memorandum of Agreement is a renewal of the MOA ending 30 June 2013 and is continuation of the benefits extended by both parties to senior citizens and persons with disability of Naga City;

WHEREAS, on the request of senior citizens, on suggestions of significant administrators, and for purposes of efficiency and convenience, certain recommendations are hereby submitted for amendments to the proposed MOA;

THEREFORE, on motion of Hon. Gregorio Re Abonal, seconded by Hon. Elmer S. Baldemoro, Hon. Mila S.D. Raquid-Arroyo and SC Councilor Virginia L. Martin;

BE IT RESOLVED, as it is hereby resolved, to authorize the City Mayor to enter into the Memorandum of Agreement effective 1 July 2018 to 30 June 2019 by and between the City Government of Naga and the SM Prime Holdings, Inc., relative to the benefits for senior citizens and persons with disabilities with recommendation to negotiate for amendments in the proposed Memorandum of Agreement;

BE IT FURTHER RESOLVED, for the City Mayor to negotiate for amendments to the previous MOA, thus:

Article II, Section (a) from "The Beneficiaries may avail of the privilege only during Mondays and/or Tuesdays" to "The Beneficiaries may avail of the privilege **only once a week on the first screening Monday thru Friday.**"


