

RESOLUTION STRONGLY RECOMMENDING TO HIS HONOR, THE CITY MAYOR THE IMMEDIATE IMPLEMENTATION OF RETROFITTING WORKS THAT SHALL COVER THREE (3) POSTS/COLUMNS FROM THE GROUND FLOOR (PORTION OF RICE SECTION) UP TO THE SECOND FLOOR (PORTION OF FRESH FISH SECTION) OF THE NAGA CITY PEOPLE'S MALL:-

**WHEREAS**, in a special session called by the Sangguniang Panlungsod, the Structural Investigation Report dated March 12, 2018 on the proposed rehabilitation of the portion of the Naga City People's Mall was presented by Engr. Salvador R. Aldecoa, a Structural Engineer, and Engr. Gaudencio A. Asis, Jr., Acting City Engineer;

**WHEREAS,** in the said report, the Structural Investigation/Assessment Team has recommended the immediate retrofitting/reconstruction of the damaged portion of the public market;

**WHEREAS**, given the necessity to find immediate remedy in order to preserve the structural stability of the damaged portion of the public market from five (5) to eight (8) more years, and to protect the safety of the market stallholders as well as the market goers in case of eventualities, Engr. Salvador R. Aldecoa has recommended the immediate retrofitting of three (3) damaged posts from the ground floor (portion of Rice Section) up to the second floor (portion of Fresh Fish Section) of the Naga City People's Mall;

**WHEREAS**, this retrofitting of three (3) damaged posts shall only cost the city government an estimated amount of more or less P1 Million Pesos, and shall not require relocation of affected stallholders that the city is expected to spend more or less P11 Million for a decent relocation site;

**WHEREAS,** this immediate remedial measure is being recommended without prejudice for a long-term plan that may require comprehensive rehabilitation or construction of a new Naga City People's Mall;

**WHEREAS**, finding this recommendation to be in order and beneficial to the city government, the market stallholders and market goers;
