On joint and collective motion

WHEREAS, on April 3, 2019, spnacity.com was defaced by a man who called himself Yoshiro;

WHEREAS, the purpose of the cyber-attack is clear ---it is to derail the city government's efforts for a clean, transparent and accountable government;

WHEREAS, the Sangguniang Panlungsod of Naga strongly denounces this cyber-attack perpetrated by ill-motivated individuals that victimized not only the Sangguniang Panlungsod of Naga as institution, but also the people of Naga as stakeholders and beneficiaries of a transparent and people-centered government;

WHEREAS, cybercrime is a crime and SP Naga cannot tolerate the same;

NOW, THEREFORE, on joint and collective motion of the 12th Sangguniang Panlungsod of Naga;

BE IT RESOLVED, as it is hereby resolved, to call upon the City Legal Office and the Information Technology Office to investigate the cyber-attack against the Sangguniang Panlungsod website and to submit its report to the Sangguniang Panlungsod within fifteen (15) days from receipt of this resolution.




