RESOLUTION RATIFYING THE DEED OF EXCHANGE EXECUTED BY AND BETWEEN THE NAGA CITY GOVERNMENT AND MR. CRISANTO R. AMAZA RELATIVE TO CERTAIN PARCELS OF LAND BOTH CONTAINING AN AREA OF TWO HUNDRED SEVENTY FOUR (274) SQUARES METERS AND LOCATED AT BARANGAY CAROLINA, NAGA CITY, FOR THE PURPOSE OF USING THE LATTER'S PROPERTY FOR ROAD EXTENSION PROJECT CONNECTING THE UNFINISHED CONCRETE ROAD BESIDE MORADA ELEMENTARY SCHOOL TO CONNECT IT ULTIMATELY TO CARARAYAN-SAN ISIDRO ROAD:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter dated 3 May 2019 of Atty. Perfecto N. Bragais III, City Legal Officer, requesting for ratification of the Deed of Exchange executed by and between the Naga City Government and Mr. Crisanto R. Amaza;

WHEREAS, the Amaza property with an area of 274 square meters covered by TCT No. 185 and Tax Declaration No. 007-892 which will be used as road extension project to connect the unfinished concrete road beside Morada Elementary School will be exchanged by a city government's property with the same area of 274 square meters covered by TCT No. 52929, and both parcels of land are located in Barangay Carolina, Naga City;

WHEREAS, per SP Resolution No. 2017-006 adopted on January 10, 2017, the Sangguniang Panlungsod authorized the Honorable City Mayor to enter into the said Deed of Exchange;






