WHEREAS, it has been noted that there is a growing number of LET examinees from Naga City and the Provinces of Camarines Sur, Camarines Norte and some areas in Masbate particularly during the months of March and September every year;

WHEREAS, at present, the testing center of the Professional Regulation Commission for Board Licensure Examination for Professional Teachers (BLEPT) is only in Legaspi City which is economically disadvantageous to LET examinees from other parts of the region;

WHEREAS, the establishment of additional PRC testing center for Board Licensure Examination for Professional Teachers (BLEPT) in the City of Naga will greatly help the LET examinees in the city as well as those coming from the Provinces of Camarines Sur, Camarines Norte and some area of Masbate;
