**RESOLUTION GRANTING MR. JERRY PEREZ, COORDINATOR OF A & J AMUSEMENT CENTER, A PERMIT TO ESTABLISH, OPERATE AND MAINTAIN A CARNIVAL AT LCC GROUND, FELIX PLAZO STREET, BARANGAY SABANG, THIS CITY, FROM AUGUST 15 TO SEPTEMBER 30, 2019, SUBJECT TO CERTAIN TERMS AND CONDITIONS:-**

**WHEREAS**, received by the Sangguniang Panlungsod for appropriate action is the letter dated July 1, 2019 of Mr. Jerry Perez, Coordinator, A & J Amusement Center, applying for a permit to operate a carnival at LCC Grounds, Felix Plazo Street, Barangay Sabang, this city;

**WHEREAS**, the Barangay Council of Sabang, through Resolution No. 2019-120, interposed no objection to application of Mr. Perez for a permit to operate the said carnival;

**WHEREAS**, SP Committee on Games and Amusement found the submitted documents in support to this application to be in order;

**NOW, THEREFORE**, on motion of Hon. Jose C. Rañola, seconded by Hon. Joselito S.A. Del Rosario and Hon. Elmer S. Baldemoro;

**BE IT RESOLVED**, as it is hereby resolved, to grant Mr. Jerry Perez, Coordinator of A & J Amusement Center, a permit to establish, operate and maintain a carnival at LCC Ground, Felix Plazo Street, Barangay Sabang, this city, from August 15 to September 30, 2019, subject to the following terms and conditions:

1. Full payment of Amusement Tax at P4,600.00 per day prior to the operation of the carnival;
2. Prizes for games must be in kind and not money as it will be considered as gambling;
3. Certification from a Mechanical Engineer and Inspection Certificate from the Office of the City Engineer as to safety of rides must be secured prior to the operation of the carnival;
4. A stand-by medics must be provided to address any untoward incident; and
5. To coordinate with the Barangay Council of Sabang for assignment of barangay tanod to maintain the peace and order in the area.
