**RESOLUTION GRANTING MR. RODOLFO B. DACALLOS, OWNER, BEE-ANN CARNIVAL, A PERMIT TO ESTABLISH, OPERATE AND MAINTAIN A CARNIVAL AT ALMEDA PROPERTY IN BARANGAY ABELLA, THIS CITY, FROM AUGUST 15 TO SEPTEMBER 25, 2019, SUBJECT TO CERTAIN TERMS AND CONDITIONS:-**

**WHEREAS**, received by the Sangguniang Panlungsod for appropriate action is the letter dated July 8, 2019 of Mr. Rodolfo B. Dacallos, Owner, Bee-Ann Carnival, applying for a permit to operate a carnival at Almeda Property in Barangay Abella, this city;

**WHEREAS**, this application of Mr. Dacallos for a permit to operate the said carnival was favorably endorsed by P/Bgy. Manuel Antonio N. Berja of Abella;

**WHEREAS**, SP Committee on Games and Amusement found the submitted documents in support to this application to be in order;

**NOW, THEREFORE**, on motion of Hon. Jose C. Rañola, seconded by Hon. Joselito S.A. Del Rosario, Hon. Mila S.D. Raquid-Arroyo and Hon. Elmer S. Baldemoro;

**BE IT RESOLVED**, as it is hereby resolved, to grant Mr. Rodolfo B. Dacallos, Owner, Bee-Ann Carnival, a permit to establish, operate and maintain a carnival at Abella Property in Barangay Abella, this city, from August 15 to September 25, 2019, subject to the following terms and conditions:

1. Full payment of Amusement Tax at P4,600.00 per day prior to the operation of the carnival;
2. Prizes for games must be in kind and not money as it will be considered as gambling;
3. Certification from a Mechanical Engineer and Inspection Certificate from the Office of the City Engineer as to safety of rides must be secured prior to the operation of the carnival;
4. A stand-by medics must be provided to address any untoward incident; and
5. To coordinate with the Barangay Council of Abella for assignment of barangay tanod to maintain the peace and order in the area.


