This Deed of Donation is made and executed by and between:

THE CITY GOVERNMENT OF NAGA, a local government unit created under the laws of the Republic of the Philippines, represented by MAYOR NELSON S. LEGACION, with office address at City Hall Building, Juan Miranda Avenue, Naga City, hereinafter referred to as the DONEE,

WITNESSETH THAT:

WHEREAS, the DONOR is the owner in fee simple of a parcel of a parcel of land located in Barangay San Felipe, Naga City with an area of Eight Thousand Three Hundred Four (8,304) square meters and covered by Transfer Certificate of Title (TCT) No. 1518 (EP No. 575930) registered with the Registry of Deeds of Naga City;
