MEMORANDUM OF AGREEMENT

This Memorandum of Agreement ("MOA") is entered into onAUG 27 2019 in by:

OFFICE OF THE VICE PRESIDENT ("OVP"), a government office existing under the laws of the Republic of the Philippines, with principal office address at No. 100, 11th Street, New Manila, Quezon City, represented by its Chief of Staff, USEC. PHILIP FRANCISCO U. DY:

LOCAL GOVERNMENT UNIT OF NAGA CITY ("LGU NAGA"), a local government unit existing under the laws of the Republic of the Philippines, with principal office address at Juan Q. Miranda Avenue, Concepcion Pequeña, Naga City, Bicol, represented by its Mayor, HON. NELSON S. LEGACION;

WHEREAS, in order to effectively bring its advocacies to the grassroots, the OVP executed a Memorandum of Agreement (MOA) with LGU Naga on September 1, 2017 for the establishment of the OVP Focal Point for the execution, coordination, and monitoring of OVP advocacy programs and initiatives;

WHEREAS, Section 6 of the MOA states that the term of the agreement shall be effective for one year, subject to renewal by the OVP;

WHEREAS, upon determination by the OVP, the MOA has been extended for one year until August 31, 2019:

WHEREAS, to ensure the continuity of the strategic partnerships and advocacy on good governance, including the execution and monitoring of the programs, it is necessary to further extend the effectivity of the MOA for another year;

NOW, THEREFORE, the Parties agree as follows:

Section 1. The OVP focal point established at LGU Naga for the execution, coordination, and monitoring of OVP programs in Bicol Region shall be further extended for one (1) year or until August 31, 2020, subject to extension or renewal by the OVP.

Section 2. All other terms of the MOA shall remain in effect unless otherwise amended in writing by the Parties.
