RESOLUTION GRANTING THE KSERVICO, REPRESENTED BY MR. RENE T. ALBALATE, STORE SUPERVISOR, A PERMIT TO CONDUCT A TEST RUN IN THE CITY OF NAGA FOR THREE (3) UNITS BAJAJ RE FOR A PERIOD OF ONE (1) MONTH, SUBJECT TO CERTAIN TERMS AND CONDITIONS:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter dated August 27, 2019 of Mr. Rene T. Albalate, Store Supervisor, Kservico, requesting for a permit to conduct test run for three (3) Bajaj RE units for a period of one (1) month;

WHEREAS, finding the conduct of a test run to be in order and necessary to determine the viability of the Bajaj RE units of Kservico;

NOW, THEREFORE, on motion of Hon. Joselito S.A. del Rosario, seconded by Hon. Elmer S. Baldemoro and Hon. Antonio B. Beltran;

BE IT RESOLVED, as it is hereby resolved, to grant the Kservico, represented by Mr. Rene T. Albalate, Store Supervisor, a permit to conduct a test run in the City of Naga for three (3) units Bajaj RE for a period of one (1) month subject to the following terms and conditions:

1. The test run shall be for the period of one (1) month only;
2. Only three (3) units of Bajaj RE shall be allowed in the test run;
3. The maximum number of passengers shall be five (5) only;
4. The units shall not be allowed to ply national roads;
5. The Traffic Management Center of the Public Safety Office shall regularly update the Sangguniang Panlungsod on the status of the test run, and to render a terminal report after the one (1) month period.

LET COPIES of this resolution be furnished His Honor, the City Mayor for his concurrence, the Kservico through Mr. Rene T. Albalate, Store Supervisor, the Naga City Police Office and the Public Safety Office for their information and guidance.
