RESOLUTION AUTHORIZING HIS HONOR, THE CITY MAYOR TO NEGOTIATE WITH BANCO FILIPINO SAVINGS & MORTGAGE BANK FOR THE POSSIBLE PURCHASE OF ITS PROPERTY IN FAVOR OF THE BARANGAY COUNCIL OF BAGUMBAYAN NORTE, NAGA CITY, AS SITE OF THE PROPOSED MULTI-PURPOSE HALL, SUBJECT TO THE RATIFICATION BY THE SANGGUNIANG PANLUNGSOD:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the 1st Endorsement dated 29 October 2019 of Mr. Cesar R. Magistrado, City Assessor, respectfully endorsing Resolution No. 2019-15 of the Naga City Appraisal Committee pertaining to the parcel of land for the proposed Multi-Purpose hall of Bagumbayan Norte, this city;

WHEREAS, in Resolution No. 27, S. 2014, the Barangay Council of Bagumbayan Norte requested the city government to purchase a parcel of land declared in the name of Banco Filipino Savings & Mortgage Bank under TCT No. 15353 with an area of 360 square meters situated adjacent to the Barangay Hall of Bagumbayan Norte;

WHEREAS, the subject property shall be used by the Barangay Council of Bagumbayan Norte as site of the Proposed Multi-Purpose Hall;

WHEREAS, finding the same to be in order and necessary in the effective and efficient delivery of basic services of the Barangay Bagumbayan Norte;

NOW, THEREFORE, on motion of Hon. Antonio B. Beltran, seconded by Hon. Elmer S. Baldemoro;

BE IT FESOLVED, as it is hereby resolved, to authorize His Honor, the City Mayor to negotiate with Banco Filipino Savings & Mortgage Bank for the possible purchase of its property in favor of the Barangay Council of Bagumbayan Norte, Naga City, as site of the Proposed Multi-Purpose Hall, subject to the ratification by the Sangguniang Panlungsod.
