RESOLUTION NO. 2019-471

RESOLUTION GRANTING THE EXPONENT MOTOR CORPORATION REPRESENTED BY MR. ERWIN E. CURIOSO, AREA MANAGER-BICOL, A PERMIT TO CONDUCT A TEST RUN IN THE CITY OF NAGA FOR THREE (3) UNITS TRIKE MOTORPOSH MOTORCYCLE FOR A PERIOD OF FORTY FIVE (45) DAYS, SUBJECT TO CERTAIN TERMS AND CONDITIONS:

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the Endorsement dated October 28, 2019 from His Honor, the City Mayor endorsing the letter dated October 2, 2019 of Mr. Erwin E. Curioso, Area Manager-Bicol, Exponent Motor Corporation, requesting for a permit to conduct test run for Motorposh Motorcycles;

WHEREAS, finding the conduct of a test run to be in order and necessary to determine the viability of the Trike Motorposh Motorcycles of Exponent Motor Corporation;

NOW, THEREFORE, on motion of Hon. Joselito S.A. del Rosario, seconded by Hon. Elmer S. Baldemoro and Hon. Vidal P. Castillo;

BE IT RESOLVED, as it is hereby resolved, to grant the Exponent Motor Corporation represented by Mr. Erwin E. Curioso, Area Manager-Bicol, a permit to conduct a test run in the City of Naga for three (3) units Trike Motorposh Motorcycle for a period of forty five (45) days, subject to the following terms and conditions:

- The test run shall be for the period of forty five (45) day only;
- 2. Only three (3) units of Trike Motorposh Trimobile shall be allowed in the test run;
- 3. The maximum number of passengers shall be nine (9) only;
- 4. The units shall not be allowed to ply national roads;
- 5. The Traffic Management Center of the Public Safety Office shall regularly update the Sangguniang Panlungsod on the status of the test run, and to render a terminal report after the forty five (45) days period.

LET COPIES of this resolution be furnished His Honor, the City Mayor for his concurrence, the Exponent Motor Corporation through Mr. Erwin E. Curioso, Area Manager-Bicol, the Naga City Police Office and the Public Safety Office for their information and guidance.
