**RESOLUTION COMMENDING THE ORGANIZATION OF BARANGAY ELECTRICIANS OF NAGA (OBEN) THROUGH ITS PRESIDENT, MR. MICHAEL BARJA FOR THE EFFORTS EXTENDED IN THE RESTORATION OF SUPPLY OF ELECTRICITY IN NAGA CITY AFTER TYPHOON TISOY:-**

On joint and collective motion

**WHEREAS**, Typhoon Tisoy brought havoc not only in Naga City but in the Bicol Region in the early days of December, this year;

**WHEREAS**, local governments all over the Bicol Region and some parts of the country that are affected by the typhoon, immediately implemented their disaster management plans particularly in addressing the restoration efforts to bring normalcy to the lives of the people;

**WHEREAS**, the Organization of Barangay Electricians (OBEN) under the leadership of its President, Mr. Michael Barja mapped out restoration strategies to restore the supply of electricity in the area coverage of the CASURECO II;

**WHEREAS**, it is a noteworthy development that the supply of electricity at CBD 1 and 2 were restored within 24 hours after the typhoon;

**WHEREAS**, in the same token, the City government under Mayor Nelson S. Legacion immediately fielded the barangay electricians in coordination with CASURECO II to join in the power restoration efforts particularly in the barangay level;

**WHEREAS**, despite some problems encountered in the power restoration, such as the issues of damaged electrical lines, posts and transformers in subdivisions which are not yet turned over to the city government and CASURECO II, the organization greatly contributed to the effort of energizing 95% of the lines after almost 10 days unrelenting efforts;


