RESOLUTION REQUESTING FROM THE CITY ENGINEER'S OFFICE A COMPLETE LISTING OF SUBDIVISIONS IN NAGA CITY WITH CORRESPONDING NOTES ON WHETHER OR NOT THEY HAVE ACTUALLY BEEN TURNED OVER TO LGU-NAGA AND CASURECO II TO ENSURE BETTER COORDINATION BETWEEN AND AMONG LGU-NAGA, CASURECO II, AND THE AFFECTED DEVELOPERS AND HOMEOWNERS :-

On joint and collective motion

WHEREAS, Typhoon Tisoy brought havoc not only in Naga City but in the Bicol Region in the early days of December, this year;

WHEREAS, local governments all over the Bicol Region and some parts of the country that are affected by the typhoon, immediately implemented their disaster management plans particularly in addressing the restoration efforts to bring normalcy to the lives of the people;

WHEREAS, in addressing the concern on the restoration of the supply of electricity in Naga City, the local government immediately fielded the barangay electricians, in coordination with CASURECO II to restore supply of electrical energy;

WHEREAS, private volunteer groups, notably the Institute of Integrated Electrical Engineers and its members also helped in this endeavor;

WHEREAS, among the major concerns faced by the restoration teams are the issues of damaged electrical lines, posts and transformers in subdivisions which are not yet turned over to the city government and CASURECO II;

WHEREAS, the lack of speedy action on the part of developers in addressing this issue gave much discomfort and inconvenience to the homeowners;

WHEREAS, with the provision of the City Engineer's Office of the complete listing of subdivisions in Naga, the homeowners can now map out their plans and actions as the situations of their roads, power lines, including transformers, will be immediately forwarded to the developers for their corresponding actions;

WHEREAS, the knowledge of this information will not immediately put LGU-Naga and CASURECO II in bad light once similar problems occur in the future;

WHEREAS, the said timely and relevant data from the City Engineers Office will help in addressing relevant issues and ensure coordination of the various agencies of the government and the electric cooperative if confronted with the same issues in the future;

NOW THEREFORE, on joint and collective motion of the 13th Sangguniang Panlungsod of Naga;

BE IT RESOLVED, as it is hereby resolved, to request from the City Engineer's Office a complete listing of subdivisions in Naga City, with corresponding notes on whether or not they have actually been turned over to LGU-Naga and CASURECO II, to ensure better coordination between and among LGU-Naga, CASURECO II, and the affected developers and homeowners.

LET COPIES of this resolution be furnished His Honor, the City Mayor for his concurrence, and the City Engineer's Office for its information and favorable consideration.
