RESOLUTION APPROVING THE APPROPRIATION ORDINANCE OF BARANGAY MABOLO, CITY OF NAGA, AS EMBODIED UNDER BARANGAY ORDINANCE NO. 003, SERIES OF 2019, INVOLVING THE AMOUNT OF ONE HUNDRED SIXTY-TWO THOUSAND NINE HUNDRED FIFTY-EIGHT PESOS AND 31/100 (P162,958.31) FOR THE GRANT OF THE ONE TIME SERVICE RECOGNITION INCENTIVES(SRI), THE SAME BEING IN CONFORMITY WITH EXISTING BUDGETARY RULES AND REGULATIONS AND IN ACCORDANCE WITH THE PROVISIONS OF THE LOCAL GOVERNMENT CODE OF 1991:-
