**WHEREAS**, received by the Sangguniang Panlungsod for appropriate action is the letter dated January 6, 2020 of Atty. Mcgyver Gerard S. Orbina of the City Legal Office requesting authority for the Honorable City Mayor Nelson S. Legacion to file the necessary action in court to compel acceptance of the deposit tendered by the City Government of Naga in payment for the Just Compensation ordered by the Regional Trial Court, Branch 26, Naga City in Civil Case No. RTC 98-4042;

**WHEREAS**, a motion for reconsideration of the said order was filed by the city government through the City Legal Office but the same was also denied per the December 18, 2019 Order of the Honorable Court;

**WHEREAS**, finding the subject request of the City Mayor to be in order,

**NOW, THEREFORE**, on motion of Hon. Mila S.D. Raquid-Arroyo, seconded by Hon. Elmer S. Baldemoro and Hon. Jose C. Rañola;
