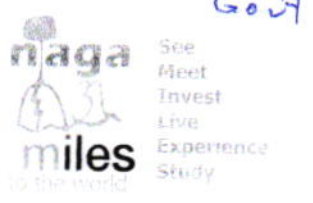

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter dated January 28, 2020 of His Honor, the City Mayor, requesting for the ratification of the Memorandum of Agreement entered into by and between the City Government of Naga and the City College of Naga relative to the use certain city government facilities to comply with the requirement of the Commission on Higher Education (CHED);

MEMORANDUM OF AGREEMENT

This Memorandum of Agreement is made and entered into by and between

The City Government of Naga, with office address at Naga City Hall Complex, J. Miranda Ave., Naga City, represented by its City Mayor, Hon. NELSON S. LEGACION, hereinafter referred to as "City Government of Naga."

and

The City College of Naga, with office address at the 2nd Floor, City Health Office, J. Miranda Av., Naga City, represented by its President, Dr. VITO C. BORJA II, hereinafter referred to as "CCN".

WITNESSETH

WHEREAS, CCN has existing classrooms and administrative offices at the 2nd Floor of the City Health Office;

WHEREAS, as part of the formal training of CCN students, there is a need for them to be exposed to actual clinical environment which the City Government of Naga is ready to provide thru the Naga City Hospital, Our Lady of Lourdes Infirmary and the Naga City Health Office

WHEREAS, in order for CCN to provide its students a holistic learning experience, there is a need for CCN to avail of the swimming pools, basketball courts, track oval, athletic grounds and other sports facilities of the City Government of Naga located at the Naga City Sports Complex in Bgy. Pacol, and the Naga City Civic Center in Bgy. Concepcion Pequena;

WHEREAS, given the limited space presently occupied by CCN, there is further a need to allow CCN to use available open spaces, halls and conference rooms of the City Government of Naga for the learning and extra-curricular activities of CCN students, particularly the following:

1. Raul S. Roco Library
2. People's Hall
3. Public Safety Office Training Hall
4. Public Safety Office Blue Room
5. Bicol Science and Technology Centrum Audio-Visual Room
6. City Health Office Conference Room
7. JMR Museum Auditorium
8. JMR Museum Cafe
9. City Hall Grounds
10. Naga City Civic Center grounds

WHEREAS, the City Government of Naga, being the entity which ordained the charter of CCN, in fact allows the use of the above facilities by the CCN and remains intent and desirous to have CCN continue to do so;

NOW THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree as follows:

Obligations of the City Government of Naga:

The City Government of Naga herein allows, as it hereby allows, the use of the following city government facilities by CCN for the latter's academic and non-academic activities, provided the same are duly sanctioned and supervised by responsible personnel of CCN and are part of the official curriculum and activities of the school:

1. Health facilities: Naga City Hospital, Our Lady of Lourdes, City Health Office Clinic
2. Swimming pools, basketball courts, track oval, athletic grounds and other sports facilities of the Naga City Government located at the Naga City Sports Complex in Bgy. Pacol, and the Naga City Civic Center in Bgy. Concepcion Pequena;
3. Open spaces, halls and conference rooms of the City Government for the learning and extra-curricular activities of CCN students, particularly the following:
 - a. Raul S. Roco Library
 - b. People's Hall
 - c. Public Safety Office Training Hall
 - d. Public Safety Office Blue Room
 - e. Bicol Science and Technology Centrum Audio-Visual Room
 - f. City Health Office Conference Room
 - g. JMR Museum Auditorium
 - h. JMR Museum Café
 - i. City Hall Grounds
 - j. Naga City Civic Center grounds
4. Except for Naga City Hall grounds, use of the facilities shall be subject to prior reservation with the City Mayor's Office;

Obligations of CCN:

CCN herein commits to use the above facilities only for official academic and non-academic activities of the school, to use them properly in accordance with their intended use, to maintain their cleanliness, and to abide with such policies and regulations of the Naga City Government on their proper use.


