RESOLUTION APPROVING THE ANNUAL BUDGET OF BARANGAY TABUCO, CITY OF NAGA FOR CALENDAR YEAR FROM JANUARY 1 TO DECEMBER 31, 2020 AS EMBODIED UNDER BARANGAY APPROPRIATION ORDINANCE NO. 2020-01, INVOLVING THE AMOUNT OF FIVE MILLION SEVEN HUNDRED THREE THOUSAND NINE HUNDRED SIXTEEN PESOS (P5,703,916.00) IN CONFORMITY WITH EXISTING BUDGETARY RULES AND REGULATIONS AND IN ACCORDANCE WITH THE PROVISIONS OF THE LOCAL GOVERNMENT CODE OF 1991:-
