**A RESOLUTION CREATING A SUB-TECHNICAL WORKING GROUP WITHIN THE SPECIAL COMMITTEE ON BARANGAY BUDGETS TO FORMULATE AND INITIATE AN ACTION PLAN TO ASSIST AND MONITOR BARANGAYS IN ORGANIZING AND EMPOWERING THEIR BARANGAY DEVELOPMENT COUNCILS AND THE FORMULATION OF THEIR RESPECTIVE BARANGAY DEVELOPMENT PLANS AND INVESTMENT PROGRAMS:-**

**WHEREAS**, SP Resolution 2020-003 created the Special Committee on Barangay Budgets to assist Barangays in the review and approval of their 2020 Barangay Budgets within the first quarter of the year and to submit its assessment and recommended measures to the City Mayor and the Sangguniang Panlungsod to ensure prompt compliance of Barangays in submitting effective and responsive Barangay Budgets for review by the Sangguniang Panlungsod;

**WHEREAS**, the Special Committee on Barangay Budgets has submitted its findings and recommendations to the City Mayor and Sangguniang Panlungsod suggesting, among others, the need for the City Government to strengthen efforts in organizing and empowering respective Barangay Development Councils of the 27 Barangays through the technical guidance of the City Planning and Development Office, in coordination with the City Budget Office, Liga ng mga Barangay and the Naga City People's Council;

**WHEREAS**, the sub-technical working group shall be tasked to formulate and initiate an action plan where the main objective of which is to assist the barangays in the formulation and monitoring of their medium-term Barangay Development Plan for 2021 to 2023 and their Annual Investment Programs; and inform the City Mayor and the Sangguniang Panlungsod of suggested legislative measures, if any; and the PPAs it shall initiate for inclusion, if necessary, in the City's Development Plan and Budget;


