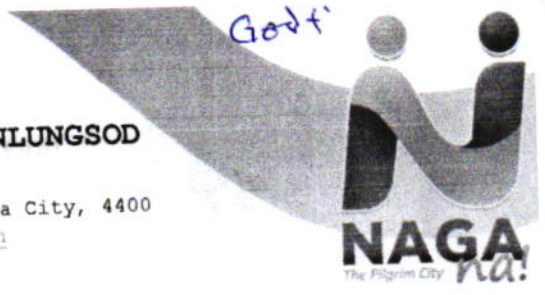

RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY AND BETWEEN THE CITY GOVERNMENT OF NAGA AND THE BARANGAY COUNCIL FOR THE PROTECTION OF CHILDREN (BCPC) OF IGUALDAD, RELATIVE TO THE TRANSFER OF THE AMOUNT OF ONE HUNDRED THOUSAND PESOS (P100,000.00) REPRESENTING THE LATTER'S CASH AWARD IN THE SEARCH FOR MOST CHILD FRIENDLY BARANGAY, TO COVER THE PURCHASE OF ONE (1) SET COMPUTER:-
