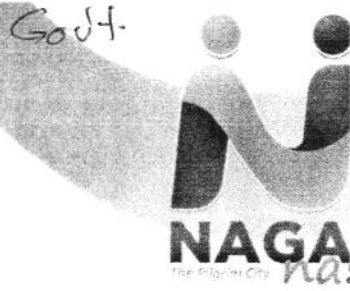

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the 1st Endorsement dated June 24, 2020 from the Acting City Administrator, Mr. Francisco M. Mendoza, endorsing for ratification the Memorandum of Agreement entered into by and between the City Government of Naga and Barangay Mabolo with regards to the transfer of financial assistance amounting to Five Hundred Thousand Pesos (P500,000.00) to carry out one of its plans, programs and activities in and linkages with local residents of city of particularly to the 27 barangays;

WHEREAS, the said amount will be allocated for payment of electric bill arrears incurred by the past administration of the barangay, and Barangay Mabolo shall no longer request for additional barangay support fund for CY 2020 and shall adhere to what has been agreed upon;

WHEREAS, this undertaking shall not serve as a precedent for other barangays to charge against the barangay support fund their electric consumption, and therefore, it is the obligation of each and every barangay government to appropriate in their annual budget the payment for electric consumption;


