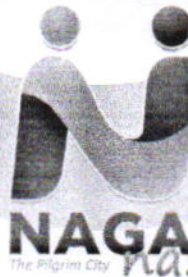

RESOLUTION RATIFYING THE COMPROMISE AGREEMENT ENTERED INTO BY AND BETWEEN THE CITY OF NAGA AND THE HEIRS OF FLAVIANO GALLARTE, REPRESENTED BY JOVITA G. ABELLANO, CONCERNING THE ACQUISITION OF A PORTION OF THE LATTER'S PROPERTY AFFECTED BY THE CITY'S SAN ISIDRO SANITARY LANDFILL ACCESS ROAD PROJECT:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter dated July 20, 2020 of Atty, Rebbekah Grace G. Maraño, Attorney II, City Legal Office, requesting for ratification of the Compromise Agreement entered into by and between the City of Naga and the Heirs of Flaviano Gallarte, represented by Jovita G. Abellano, concerning the acquisition of a portion of the latter's property affected by the San Isidro Sanitary Landfill Access Road Project of the city;

WHEREAS, the acquisition of this property is the subject of an expropriation case docketed as Special Civil Case No. 2017-0127, City of Naga versus Flaviano Gallarte, pending before Branch 23 of the Regional Trial Court of Naga City;

WHEREAS, per Resolution No. 2020-09, the City Appraisal Committee determined the fair market value of the subject land located in Barangay San Isidro, this city, intended for public use;

WHEREAS, after Court's decision based on Compromise to be rendered, the corresponding Deed of Conveyance shall be executed, subject to the ratification by the Sangguniang Panlungsod;

WHEREAS, copy of the said Compromise Agreement is hereto attached as integral part of this resolution.

NOW, THEREFORE, on motion of Hon. Salvador M. del Castillo, seconded by Hon. Joselito S.A. del Rosario and Hon. Elmer S. Baldemoro;


