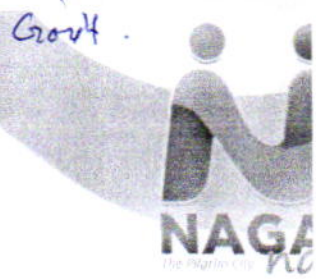

RESOLUTION AUTHORIZING HIS HONOR, THE CITY MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT AND DEED OF DONATION WITH TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA) RELATIVE TO A CITY-ACQUIRED ALMEDA PROPERTY, DESIGNATED AS LOT 3, PSD-05-036738, MEASURING 2,730 SQUARE METERS LOCATED ALONG ALMEDA HIGHWAY, BARANGAY CONCEPCION GRANDE, THIS CITY, IN FAVOR OF THE LATTER FOR THE ESTABLISHMENT OF TESDA HUB: THE METRO NAGA SKILLS AND DEVELOPMENT CENTER, SUBJECT TO THE RATIFICATION BY THE SANGGUNIANG PANLUNGSOD:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter dated 4 August 2020 of His Honor, the City Mayor, requesting for authority to enter into a Memorandum of Agreement and Deed of Donation with the Technical Education and Skills and Development Center (TESDA) relative to the establishment of TESDA HUB: The Metro Naga Skills and Development Center at the city-owned property along Almeda Highway, Barangay Concepcion Grande, this city;

WHEREAS, this Memorandum of Agreement and Deed of Donation of a parcel of land in favor of the TESDA shall be utilized in the establishment of TESDA HUB: The Metro Naga Skills and Development Center which will house its Innovation Center, Provincial Training Center and Camarines Sur Provincial Office;

WHEREAS, finding the grant of this authority to be in order and necessary as it will provide an accessible education to the Nagaeños, and inclusive growth in the city;
