

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is copy of Resolution No. 2020-007-025 of the Barangay Council of Abella, this city, requesting financial assistance in connection with its Barangay Day Celebration on August 15, 2020;

WHEREAS, finding this financial assistance to be in order and necessary in making this year's celebration more colorful and memorable to the barangay constituents;

NOW, THEREFORE, on joint and collective motion of the 13th Sangguniang Panlungsod of Naga;

BE IT RESOLVED, as it is hereby resolved, to authorize the City Treasurer and the City Accountant to disburse the amount of Twenty Thousand Pesos (P20,000.00) as financial assistance to the Barangay Council of Abella, Naga City, in connection with its Celebration of Barangay Day to be held on August 15, 2020, chargeable against the Barangay Support Fund, provided that the activities to be funded should be carried out in compliance with the protocol for COVID-19.
