**RESOLUTION AUTHORIZING HIS HONOR, THE CITY MAYOR TO ENTER INTO AN AGREEMENT WITH THE PROVINCE OF CAMARINES SUR AND OTHER INVOLVED PARTIES FOR THE PURPOSE OF ACQUIRING PORTION OF THEIR PROPERTIES LOCATED AT BARANGAY CONCEPCION PEQUEÑA, NAGA CITY, THAT WILL BE AFFECTED IN THE ESTABLISHMENT OF SAN VICENTE-DALIPAY BYPASS ROAD PROJECT, SUBJECT TO THE RATIFICATION BY THE SANGGUNIANG PANLUNGSOD:-**

**WHEREAS**, received by the Sangguniang Panlungsod for appropriate action is the letter dated July 7, 2020 of His Honor, the City Mayor requesting for authority to negotiate with Mr. Jose Manalang for the purpose of acquiring 5,192 square-meter portion of the latter's property located at Barangay Concepcion Pequeña, Naga City, for the intended establishment of San Vicente-Dalipay Bypass Road;

**WHEREAS**, the said project intends to ease the traffic at the main roads of Naga city especially at the Diversion Road that stretches from Almeda Highway to Maharlika Highway at the Naga-Milaor Boundary;

**WHEREAS**, finding this grant of authority to be in order and necessary in the acquisition of properties for the establishment of San Vicente-Dalipay Bypass Road;
