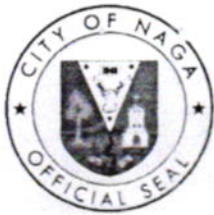


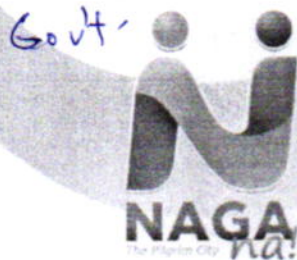

RESOLUTION AUTHORIZING HIS HONOR, THE CITY MAYOR, TO ENTER INTO A DEED OF USUFRUCT FOR TWENTY FIVE (25) YEARS WITH PHILIPPINE DENTAL ASSOCIATION-CAMARINES SUR CHAPTER RELATIVE TO THE USE OF A CITY PROPERTY COVERING AN AREA OF ONE HUNDRED FIFTY (150) SQUARE METERS WITHIN THE CITY HALL COMPOUND, SUBJECT TO THE RATIFICATION BY THE SANGGUNANG PANLUNGSOD:-

WHEREAS, submitted to the Sangguniang Panlungsod for appropriate action is the proposed Deed of Usufruct to be entered into by and between the City Government of Naga and the Philippine Dental Association-Camarines Sur Chapter relative to the use of its building within the City Hall Compound;

WHEREAS, the subject building will be exclusively used by the Philippine Dental Association-Camarines Sur Chapter as its medical clinic to serve indigent patients needing free dental services;

WHEREAS, for this purpose, the Philippine Dental Association-Camarines Sur Chapter will extend free dental and oral treatment to indigent and pregnant women of the city two (2) times a month;

WHEREAS, this will enhance the city's dental programs and projects for indigent families;

WHEREAS, finding the same to be in order and beneficial to the city government and the Nagueños;

NOW, THEREFORE, on motion of Hon. Jose C. Rañola, seconded by Hon. Ghriel G. Rosales, Hon. Joselito S.A. del Rosario, Hon. Mila S.D. Raquid-Arroyo, Hon. Elmer S. Baldemoro and Hon. Jessie R. Albeus;

BE IT RESOLVED, as it is hereby resolved, to authorize His Honor, the City Mayor, to enter into a Deed of Usufruct for Twenty Five (25) years with Philippine Dental Association-Camarines Sur Chapter relative to the use of a property covering an area of One Hundred Fifty (150) square meters within the City Hall Compound, subject to the ratification by the Sangguniang Panlungsod.
