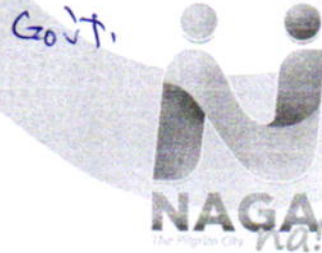

WHEREAS, the City of Naga, like other local government units in the entire country, is facing challenges in strictly implementing protocols on COVID-19 Pandemic that eventually compromises the peace and order in the locality;

WHEREAS, PCOL Marlon M Catan was designated as Officer-In-Charge of the Naga City Police Office when then City Director, PCOL Felix Nepomuceno Servita retired from service sometime in June this year;

WHEREAS, there is a need to strengthen the police force of the Naga City Police Office in order to strictly implement the protocols on COVID-19 Pandemic and other peace and order concerns of the city;


