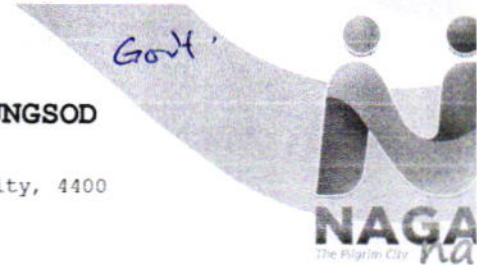

RESOLUTION AUTHORIZING HIS HONOR, THE CITY MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH)-REGION V, RELATIVE TO THE CONSTRUCTION OF QUARANTINE/ISOLATION FACILITIES IN NAGA CITY, SUBJECT TO THE RATIFICATION BY THE SANGGUNIAN PANLUNGSOD:-

On joint and collective motion

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the 1st Indorsement dated September 4, 2020 from His Honor, the City Mayor requesting for authority to enter into a Memorandum of Agreement with the Department of Public Works & Highways (DPWH) Region-V relative to the construction of quarantine/isolation facilities in the city;

WHEREAS, due to the continuing fight against COVID-19 pandemic, the city government requested the assistance of the DPWH in constructing quarantine/isolation facilities and/or providing shelters for frontliners and other healthcare workers to alleviate the daily operational challenges during this crisis;

WHEREAS, through the FY 2020 General Appropriations Act (GAA), the DPWH will fund this proposed project which is deemed beneficial to the city government to effectively address the increasing number of COVID-19 cases in the city;

WHEREAS, finding this grant of authority to be in order and necessary in the realization of this project;

NOW, THEREFOR, on joint and collective motion of the 13th Sangguniang Panlungsod of Naga;

BE IT RESOLVED, as it is hereby resolved, to authorize His Honor, the City Mayor to enter into a Memorandum of Agreement with the Department of Public Works and Highways (DPWH)-Region V, relative to the construction of quarantine/isolation facilities in Naga City, subject to the ratification by the Sangguniang Panlungsod.
