**RESOLUTION APPROVING THE 2020 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM OF THE CITY GOVERNMENT OF NAGA AMOUNTING TO NINE HUNDRED FORTY MILLION SEVEN HUNDRED THIRTY THOUSAND PESOS (P940,730,000.00) :-**

**WHEREAS,** received by the Sangguniang Panlungsod for appropriate action is the letter dated 20 August 2020 of Mr. Wilfredo B. Prilles, Jr., City Planning & Development Officer, submitting for consideration the proposed 2020 Supplemental Annual Investment Program of the city government amounting to P940.73 Million;

**WHEREAS,** this Supplemental Annual Investment Program consists of three parts: (a) a COVID-19 Action Plan package amounting to P138.5 Million to be funded by savings to be generated under the current budget; (b) the Bayanihan Grant for Cities and Municipalities amounting to P57.65 Million which was already expended for the city's COID-19 response during the Luzon lockdown; and (c) other Essential Expenditures amounting to P744.6 Million;

**WHEREAS,** the said 2020 Supplemental Annual Investment Program is hereto attached as integral part of this resolution;

**WHEREAS,** finding the same to be in order;

**NOW, THEREFORE,** on motion of Hon. Salvador M. del Castillo, seconded by Hon. Joselito S.A. del Rosario, Hon. Elmer S. Baldemoro, Hon. Jose C. Rañola and Hon. Jessie R. Albeus;

**BE IT RESOLVED,** as it is hereby resolved, to approve the 2020 Supplemental Annual Investment Program of the City Government of Naga amounting to Nine Hundred Forty Million Seven Hundred Thirty Thousand Pesos (P940,730,000.00).




