RESOLUTION RATIFYING THE DEED OF DONATION ENTERED INTO BY AND BETWEEN THE NAGA CITY GOVERNMENT AND THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA) INVOLVING A CITY-ACQUIRED ALMEDA PROPERTY, DESIGNATED AS LOT 3, PSD-05-036738, MEASURING 2,730 SQUARE METERS LOCATED ALONG ALMEDA HIGHWAY, BARANGAY CONCEPCION GRANDE, THIS CITY, IN FAVOR OF THE LATTER FOR THE ESTABLISHMENT OF TESDA HUB: "THE METRO NAGA SKILLS AND DEVELOPMENT CENTER":-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the 1st Indorsement dated September 4, 2020 from His Honor, the City Mayor endorsing for ratification the Deed of Donation entered into by and between the Naga City Government and the Technical Education and Skills Development Authority (TESDA) involving a city-acquired Almeda Property, designated as Lot 3, Psd-05-036738, measuring 2,730 square meters located along Almeda Highway, Barangay Concepcion Grande, this city, in favor of the latter for the establishment of TESDA Hub: "The Metro Naga Skills and Development Center";
