RESOLUTION APPROVING THE ANNUAL BUDGET OF SANGGUNIANG KABATAAN OF BARANGAY TABUCO, CITY OF NAGA FOR CALENDAR YEAR FROM JANUARY 1 TO DECEMBER 31, 2020 AS EMBODIED UNDER BARANGAY APPROPRIATION ORDINANCE NO. 001-2020 INVOLVING THE AMOUNT OF FIVE HUNDRED SEVENTY THOUSAND THREE HUNDRED NINETY ONE PESOS & 60/100 (P570,391.60) IN CONFORMITY WITH EXISTING BUDGETARY RULES AND REGULATIONS AND IN ACCORDANCE WITH THE PROVISIONS OF THE LOCAL GOVERNMENT CODE OF 1991:-
