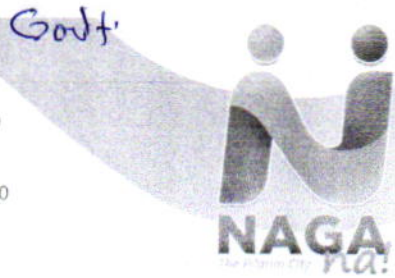

RESOLUTION APPROVING THE ANNUAL BUDGET OF BARANGAY SAN FRANCISCO, CITY OF NAGA FOR CALENDAR YEAR FROM JANUARY 1 TO DECEMBER 31, 2021 AS EMBODIED UNDER BARANGAY APPROPRIATION ORDINANCE NO. 20-002, INVOLVING THE AMOUNT OF FOUR MILLION SEVEN THOUSAND SEVEN HUNDRED EIGHTY EIGHT PESOS (P4,007,788.00) IN CONFORMITY WITH EXISTING BUDGETARY RULES AND REGULATIONS AND IN ACCORDANCE WITH THE PROVISIONS OF THE LOCAL GOVERNMENT CODE OF 1991:-
