**WHEREAS,** received by the Sangguniang Panlungsod for appropriate action is the letter dated 5 October 2020 of His Honor, the City Mayor, requesting for authority to negotiate with Maria Socorro Vda. De Reanto, owner of that parcel of land, measuring 0.984200 has., located into located at Zone 5, Barangay Balatas, Naga City, for the acquisition thereof to be used as site of the Balatas High School;

**WHEREAS,** the subject lot which is across the Balatas elementary School is very suitable and strategic for the realization of the city's aspiration of building a high school in the area and in improving the access of Nagueños to quality education;

**WHEREAS,** the City Planning & Development Office has already incorporated the subject property among the institutional zone for the Balatas government site, and shall be included in the final City Land Use Plan (CLUP) and Zoning maps;

**WHEREAS,** finding the grant of this authority to be in order and necessary in the common objective of building a self-reliant and caring city;

**BE IT RESOLVED,** as it is hereby resolved, to authorize His Honor, the City Mayor to negotiate with Maria Socorro Vda. De Reanto, a landowner, to acquire her property located at Zone 5, Barangay Balatas, Naga City, which will be used as site of the Balatas High School, subject to the ratification by the Sangguniang Panlungsod.


