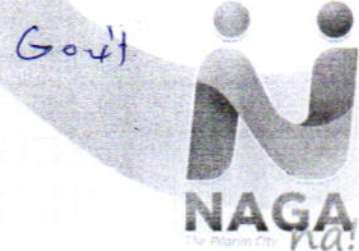

WHEREAS, the economic downturn caused by the coronavirus disease 2019 (COVID-19) pandemic has put a severe strain on the ability of families and individuals to afford basic needs, such as education;

WHEREAS, to remedy the disruption felt by many families and help them send their children back to school, financial aid should be made available to them;

WHEREAS, the government must enable the children and the youth to continue their education despite the pandemic and must exhaust all means to help them realize their right to education;

WHEREAS, on the strength of the fact that the national government, through the Department of Budget and Management, has been providing assistance to local government units in the fight against the devastation brought about by COVID-19;
