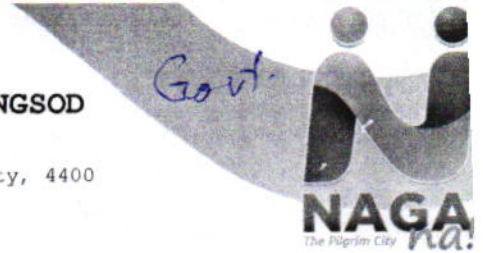

**WHEREAS**, in the morning of November 1, 2020, Naga City and the Bicol Region were battered by Super Typhoon Rolly leaving enormous destructions and damages to various infrastructures and properties affecting the whole of Naga and leaving residents without shelter and food and other immediate necessities;
