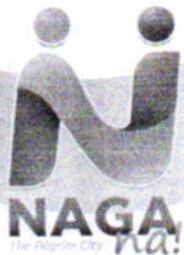

RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY AND BETWEEN THE CITY GOVERNMENT OF NAGA AND THE OFFICE OF THE VICE PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES IN CONNECTION WITH THE FINANCIAL ASSISTANCE AMOUNTING TO FIVE MILLION PESOS (P5,000,000.00) FOR THE CONSTRUCTION OF A MODULAR RT-PCR LABORATORY IN NAGA CITY WHICH WILL BE SET UP AT THE NAGA CITY NURSERY:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter dated November 23 ,2020 of His Honor, the City Mayor requesting for the passage of a resolution ratifying the Memorandum of Agreement entered into by and between the City Government of Naga and the Office of the Vice President in connection with the financial assistance amounting to Five Million Pesos (P5,000,000.00) for the construction of a Modular RT-PCR Laboratory in Naga City which will be set up at the Naga City Nursery;

WHEREAS, the said project is under the Angat Buhay, a flagship program of the Office of the Vice President whose fund can be accessed by local government units who wish to receive financial assistance and has the capacity to implement a project most beneficial to its constituents;

WHEREAS, finding this ratification of the Memorandum of Agreement to be in order and necessary in the establishment of a Modular RT-PCR Laboratory which is vital in the city's fight against the spread of COVID-19;
