RESOLUTION AUTHORIZING HIS HONOR, THE CITY MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DENR-PENRO-CAMARINES SUR, THE BARANGAY GOVERNMENTS OF SAN FRANCISCO, DINAGA AND STA. CRUZ, AND THE UNIVERSITY OF NUEVA CACERES RELATIVE TO THE PROTECTION OF CENTURY-OLD TREES IN PLAZA RIZAL, QUINCE MARTIRES AND IN THE UNIVERSITY OF NUEVA CACERES, SUBJECT TO THE RATIFICATION BY THE SANGGUNIANG PANLUNGSOD:-

On joint and collective motion

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter dated December 1, 2020 of PENRO Officer, Ms. Grace L. Cariño, and in open session, she presented before the Body her dissertation, entitled: "Developing an Urban Plan Promoting Cultural Heritage and Protection of Natural Resources through the Design Thinking Process" aimed at protecting the century trees along Plaza Rizal, Quince Martires, and inside the University of Nueva Caceres;

WHEREAS, a total of Nine (9) Century Trees were identified in the three (3) areas;

WHEREAS, finding the grant of this authority to His Honor, the City Mayor to enter into the said Memorandum of Agreement to be in order and necessary in promoting cultural heritage and in protecting century-old trees in the three (3) identified areas, and later in the entire City of Naga;

NOW, THEREFORE, on joint and collective motion of the 13th Sangguniang Panlungsod of Naga;

BE IT RESOLVED, as it is hereby resolved, to authorize His Honor, the City Mayor to enter into a Memorandum of Agreement with the DENR-PENRO-Camarines Sur, the Barangay Governments of San Francisco, Dinaga and Sta. Cruz, and the University of Nueva Caceres relative to the protection of century-old trees in Plaza Rizal, Quince Martires and in the University of Nueva Caceres, subject to the ratification by the Sangguniang Panlungsod.


