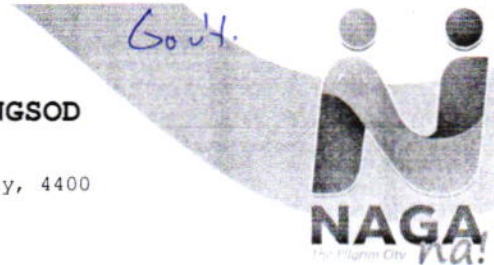

RESOLUTION RATIFYING THE EXTRAJUDICIAL SETTLEMENT OF ESTATE OF THE LATE ERNESTO SAN JUAN WITH DONATION OF A PORTION OF THEIR PROPERTY TO THE CITY GOVERNMENT OF NAGA THAT SHALL SERVE AS AN ACCESS ROAD FOR THE RESIDENTS OF LIBERTY SUBDIVISION, A CITY RESETTLEMENT SITE IN BARANGAY CARARAYAN, NAGA CITY:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter dated December 21, 2020 of Atty. Rebbekah Grace G. Maraño, Attorney II, City Legal Office, respectfully requesting for the ratification of the Extrajudicial Settlement of Estate of the late Ernesto San Juan with Donation of a portion of their property to the city government. The portion donated shall serve as an access road for the residents of Liberty Subdivision, a city resettlement site in Barangay Cararayan, this city;

WHEREAS, on August 17, 2020, the Sangguniang Panlungsod adopted Resolution No. 2020-276 authorizing His Honor, the City Mayor, to negotiate with the heirs of Ernesto San Juan for the acquisition, through donation or sale, of a piece of land situated in Sitio San Rafael, Barangay Cararayan, this city, which will be traversed by the proposed road to Liberty Subdivision, subject to the ratification by the Sangguniang Panlungsod;

WHEREAS, acquiring this property is necessary to ensure the residents' unhampered access to Liberty Subdivision;

NOW, THEREFORE, on motion of Hon. Mila S.D. Raquid-Arroyo, seconded by Vidal P. Castillo and Hon. Jose C. Rañola;

BE IT RESOLVED, as it is hereby resolved, to ratify the Extrajudicial Settlement of Estate of the late Ernesto San Juan with Donation of a portion of their property to the City Government of Naga that shall serve as an access road for the residents of Liberty Subdivision, a city resettlement site in Barangay Cararayan, Naga City.
