

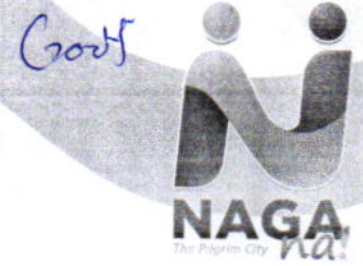

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the 1st Indorsement dated December 28, 2020 from His Honor, the City Mayor, endorsing the draft Memorandum of Agreement to be entered into by and between the city Government of Naga and the Department of Social Welfare and Development (DSWD) relative to the provision of emergency subsidy as mandated under Republic Act No. 11494 or the "Bayanihan to Recover as One Act";

WHEREAS, the provision of financial assistance to beneficiaries is in accordance with DSWD Memorandum circular No. 11, Series of 2019 of the Revised Guidelines in the Implementation of the Assistance to Individuals in Crisis Situation (AICS);


