RESOLUTION EARNESTLY REQUESTING CASURECO II, ENGINEER'S OFFICE, BUREAU OF FIRE PROTECTION TO CONSOLIDATE THEIR EFFORTS TO EXTEND ALL POSSIBLE FORMS OF ASSISTANCE TO THE BICOL MEDICAL CENTER SO THAT SOME OF ITS CRITICAL FACILITIES BE ENERGIZED AND ITS SERVICES BE MADE AVAILABLE TO THE PUBLIC: -

WHEREAS, new 8 story and 5 story buildings were constructed inside the Bicol Medical Center premises several years ago;

WHEREAS, it was learned that up to the present, the Cardiac Center and other operating rooms are not yet functional because problems related to electrical connection were encountered;

WHEREAS, the equipment in the Cardiac Centerconsidered at par with the best private hospitals in Manila-are left idle up to this time, including those intended for other operating rooms;

WHEREAS, Bicolanos deserve access to these facilities as being vigorously pursued by the Bicol medical Center

WHEREAS, there is a pressing need for CASURECO II, City Engineer's Office, Bureau of Fire Protection to urgently discuss this matter and assist the Bicol Medical Center find the necessary solution so that its services be made available to all of us;
