

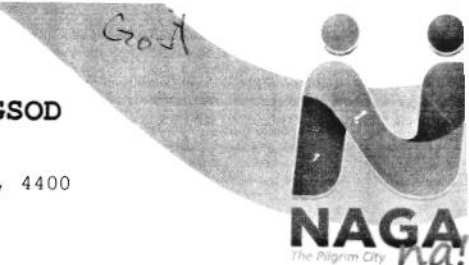

Bongalonta, City Agriculturist, requesting for the passage of a resolution approving the purchase of a service vehicle, chargeable against the Corn Quality Achievers Award that the City Government of Naga won in year 2017 amounting to One Million Pesos (P1,000,000.00);
