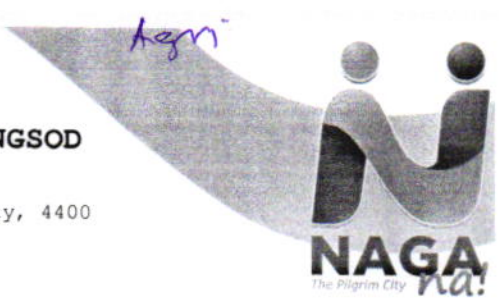

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the 1st Indorsement dated March 16, 2021 from His Honor, the City Mayor requesting for the passage of a resolution authorizing him to enter into a Memorandum of Agreement with the Department of Agriculture-Regional Field Office No.5, relative to the purchase of Mushroom House and other inputs;


