## ADMINISTRATIVE ORDER NO. 2013-003

## CONSTITUTING A COMMITTEE TO STUDY AND REVIEW CITY ORDINANCE NO. 2002-049 AND RELATED ORDINANCES IN VIEW OF THE IMPENDING EXPIRATION ON JULY 17, 2013 OF THE 5-YEAR CENTRAL BUS TERMINAL MANAGEMENT AGREEMENT THAT THE CITY GOVERNMENT EXECUTED WITH FPM CORPORATION: -

WHEREAS, the five-year Central Bus Terminal Management Agreement executed between the City Government of Naga and FPM Corporation – duly ratified by the Sangguniang Panlungsod on 15 July 2008 and Notice of Ratification of which was received by FPM Corporation on 17 July 2008 – is due to expire on 17 July 2013;

WHEREAS, City Ordinance No. 2002-049, in relation to Ordinance No. 2002-048 and Ordinance No. 2002-047, created the Central Bus Terminal Committee and its ancillary bodies and set the procedures for the selection of the best offer to operate the terminal;

WHEREAS, in view of the passage of time and the happening of supervening events, the local chief executive deemed it proper that certain provisions of City Ordinance No. 2002-049 be reviewed, reevaluated, reengineered and/or integrated with other relevant ordinances in order to make the operation of the terminal more efficient and the terminal more modern;

WHEREAS, there is a need to constitute a committee that will thoroughly study and review the above ordinances to ensure that the city government shall secure the most advantageous offer or arrive at the best option, guarantee a more transparent and competitive bidding process in the selection of the Central Bus Terminal operator, or prepare to operate the terminal pursuant to options available under relevant ordinances;

NOW THEREFORE, I, JOHN G. BONGAT, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

Section 1. A committee of five, to be called the Central Bus Terminal Ordinance Review Committee, is hereby constituted to be composed of the City Budget Officer as Chairman and with the City Administrator, City Legal Officer, City Planning and Development Officer and City Treasurer, as members. To protect the integrity of the Committee and in the spirit of transparency and fair play, the Chairman and members thereof are henceforth directed to refrain from talking or communicating, directly or indirectly, to/with the existing operator or any applicant/prospective applicant and/or his/her/its representative(s), except as a committee acting in an official capacity; provided, further, that the minutes of any such official meeting shall be recorded, for reference purposes. Any written communication from the said parties shall, at all times, be recorded as part of the proceedings of the committee.

Section 2. Within five (5) days from the issuance of this administrative order, the committee shall study and review the provisions of City Ordinance No. 2002-049, in relation to Ordinance No. 2002-048 and Ordinance No. 2002-047, and recommend to the City Mayor actions that he may undertake to attain the above-mentioned objectives.

Section 3. This Administrative Order shall take effect immediately.
