ADMINISTRATIVE ORDER NO. 2014-001

DIRECTING ALL OFFICES IN CHARGE OF PROCESSING PERMITS/CLEARANCES TO PUT ON HOLD ALL RENEWAL OR NEW APPLICATIONS FOR POULTRY AND PIGGERY AND CONSTITUING A COMPOSITE TEAM TO EVALUATE REPORTS ON FLY INFESTATION AND POLLUTION BROUGHT ABOUT BY UNSANITARILY MANAGED POULTRY AND PIGGERY FARMS IN THE UPPER BARANGAYS OF NAGA.

WHEREAS, numerous complaints were received by this office on fly infestation and unpleasant odor emanating from swine and poultry farms in the upper barangays of Naga brought about by unsanitarily managed poultry and piggery farms or built without appropriate permits and/or clearances from the city and/or concerned national government agencies;

WHEREAS, if remained unacted by the city government the infestations shall be a continuing hazard to human health and pollution control will be left unaddressed;

NOW THEREFORE, I, JOHN G. BONGAT, Mayor of the City of Naga, do hereby order the following:

1. All offices in charge of processing permits/clearances shall put on hold ALL renewal or new applications for poultry and piggery. All existing poultries/piggeries found within the territorial jurisdiction of the City of Naga must be inspected immediately and appropriate recommendations for suspension or closure shall be submitted on or before January 5, 2015.
2. All application documents for issuance of Mayor's Permit for 2015 that may be filed must be forwarded immediately to the City Administrator for review.
3. A Composite Team comprised of heads of the following offices are hereby tasked to 1) conduct an immediate assessment of the situation and submit recommendations to the City Mayor within two weeks but not later than Jan. 5, 2015, and 2) draft an ordinance that will prohibit expansion of any existing piggery/poultry and construction of new ones, to wit:
 - a. City Environment and Natural Resources Office
 - b. City Treasurer's Office

- c. City planning and Development Office
 - d. City Health Office
 - e. Solid Waste Management Office
 - f. City Agriculture Office
 - g. Arts, Culture and Tourism Office
 - h. City Events, Protocol and Public Information Office
4. The City Environment and Natural Resources Officer shall serve as chairman of the team.
 5. This Administrative Order shall become effective immediately.
 6. Let copies of this order be furnished all concerned for their appropriate action and the Sangguniang Panlungsod for their information, and in aid of legislation.
